A bylaw for imposing taxes upon lands in the District and to provide for imposing a percentage addition to encourage prompt payment thereof.

The Trustees of the Union Bay Improvement District **ENACT AS FOLLOWS:**

1. For the year 2017 there is hereby levied the following taxes:
 - (a) A tax of \$345.00 on all parcels of land classified into Group "A".
 - (b) A tax of \$0.00 on all parcels of land classified into Group "B".
2. The first installment of \$172.50 shall be due and payable on or before the 2nd day of March 2017. The second installment of \$172.50 shall be due and payable on the 31st day of August 2017. A percentage addition of ten per centum (10%) of the amount thereof shall be added to all taxes remaining unpaid after the said dates.
3. In addition, taxes remaining unpaid on the 1st day of March next following the date upon which taxes are levied shall bear interest at the rate prescribed by the Lieutenant-Governor in Council under the Taxation (Rural Area) Act, as set out under Section 717 of the *Local Government Act*.
4. This bylaw may be cited as the "Taxation Bylaw, 2017"


